



## How to find us

### Directions:

Take A30 to Launceston (off M5 from Exeter)

Take turn-off to Launceston

#### **From the west:**

At T-junction just off A30 turn right going under the road to the roundabout.

#### **From the east:**

Take slip road to roundabout.

#### **From either direction:**

At roundabout take 3<sup>rd</sup> (from east) or 4<sup>th</sup> (from west) exit onto the Pennygillam Industrial estate

Follow the estate road for about a mile, almost as far as you can - past Kensey Foods (large on the right) and The Environment Agency (with windmill) on the left.

The road bends right, then sharply left and our Mill is on the right just as the road begins to slope upwards.

The building has a sign saying The Natural Fibre Company, partly obscured by trees when in leaf, and is long and set sideways to the road and we are in the first part, nearest the road.

Turn right into Pipers Court and immediately left into the car park.

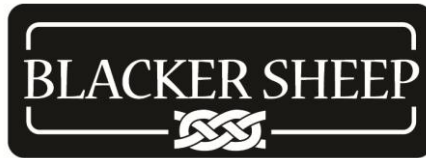
The next-door unit is Car Parts Direct and the opposite end of our building is Cornish Grumpies.

If you go farther up the slope the road ends at Charley Bears and there are some other units and gas storage tanks.
